Call Meeting to Order: Mayor Kevin Hemstock called the meeting to order at 6:30 pm.

Kent County Sheriff's Report: Captain Kettner reviewed the report with Council

Town Administrator Report: Admin Manning reviewed her report with Council, provided an update on the senior housing project and community/business center project and shared the audit has started. She also shared the county is giving her a hard time about the fireman tax credit.

Old Business: Admin Manning gave the council a letter request to relinquish 1 EDU and waiver of additional expenses due to the EDU from 415 Cypress St, Mr. Starkey would like to sell the empty lot, with some decision from the council. A motion to relinquish the EDU and waive additional expense made by Council Starkey and a second by Council Seals, a vote of 4-0 was entered.

Admin Manning asked the Council if the town could reopen the Commercial Façade Program, since we only had two that applied for it, the council agreed to reopen the Commercial Façade Program. It will help the business in town to update the front of their buildings.

Admin Manning asked the council if they had a change for Chapter 34- Flood Plains. The council decided not to change anything in the chapter, it follows all state guidelines.

Mayor Hemstock introduced-Resolution 2024-14-A resolution to adopt Construction Standards & Specification of Kent County, Maryland.

Mayor Hemstock introduced- Resolution 2024-15- A resolution to adopt Construction Standards & Specifications of Queen Anne's County, Maryland.

Mayor Hemstock introduced- Resolution 2024-16- A resolution to amend Chapter 48-Peace and Good Order.

Mayor Hemstock introduced-Resolution 2024-17-Cannabis- Medicinal & Recreational.

New Business: Austen Parish (On Phone) explained how RiverNet works a lot like EastCoast WiFi with antennas. He has a couple of properties in town, and he is trying to make their service better for them and since he is a small company he can't afford the rent on the water tower. Council Seals asked Mr. Parish about cell phone service because that is the biggest problem Millington residents have at this time. Mr. Parish said there is really nothing he could do to improve that, but he is willing to work some tricks if he gets more people to get his service in town limits. The council thanked Mr. Parish for taking the time out of his schedule to explain his service for internet, they will have to talk about it.

Admin Manning asked the council if they would want to put a deed restriction on 172 Sassafras property. The deed restriction would keep it as senior housing, in case home partnership decides, they aren't going to run the complex anymore. The council agrees that the town should deed restrict 172 Sassafras Street.

Mayor Hemstock asked Admin Manning what is going on with the electric at the new shed, she explained she is waiting for Frank, he said he would take care of it because the cost is \$20,000 to run it back there.
